Justice For All?

Don't oversleep Sunday morning because you won't want to miss Dr. Uffe Juul Jensen, an international scholar in the field of philosophy and medical ethics from the University of Aarhus in Denmark. He will discuss the prospects for social justice in health in the age of evidence-based medicine and explore how these issues confront us daily, from choices we make through evidence-based practice to ethical dilemmas imposed by managed care. Dr. Jensen's research includes studies of the concepts of illness, disease and health, the welfare state versus the market, the individual person, the community, and the state. He does some of his research in collaboration with his wife, Dr. Tove Borg, an occupational therapist with expertise in clinical reasoning.
