



## Greetings to Research Resource Colleagues!

The health care debate is receiving a lot of press lately and rightfully so. The dialog is certainly of great importance to OT researchers and practitioners. I had the opportunity to attend a meeting at the National Academy of Medicine a few weeks ago where the conclusive final paper in the "[Vital Directions](#)" series was released. The NAM called on more than 150 leading experts across the country to assemble evidence-based strategies for advancing health and health care. This resulted in 19 topic-specific discussion papers published earlier and the [final compilation paper](#) just released. This non-partisan road map of essential changes that need to be made outlined four key priorities for action and four essential infrastructure needs.

While listening to the speakers at the meeting it became dear to me that OTs, with their unique perspective and skill set, have an important role to play in the essential changes suggested. Calls to empower people (clients/patients), activate communities, measure what matters most, and advance science are particularly in the wheelhouse of the OT profession. I thought the dialog represented in these 20 papers was required reading for all, so we have dedicated this "Research Resources" to this topic. I hope you find the content of value and will inform you as you plan that next research project or look for support to implement innovative evidence-based practice strategies.

In the coming months, Research Resources will take a closer look at each of these 19 topics.

## From the President of the National Academy of Medicine

Last month, as the nation awaited a vote on the proposed American Health Care Act, we released "[Vital Directions for Health and Health Care: Priorities from a National Academy of Medicine](#)," the conclusive final publication in our Vital Directions series. This publication, authored by the initiative's steering committee, synthesizes and prioritizes the advice of more than 150 experts around the country in 19 papers to provide a streamlined framework for progress. The framework recommends four key action priorities-pay for value, empower people, activate communities, and connect care-and four essential infrastructure needs-measure what matters most, modernize skills, accelerate real-world evidence, and advance science. The NAM Perspective and the accompanying special communication in the *Journal of the American Medical Association* are now available for download.

The health challenges facing our nation go far beyond insurance coverage. As policy makers consider what's next for health reform, we intend for the Vital Directions series to serve as a roadmap for measurable progress toward better health and well-being, high-value health care, and strong science and technology. ## Postdoctoral Fellow – The Lurie Institute for Disability Policy

## **Postdoctoral Fellow Position Washington University School of Medicine in St. Louis**

One position is available for a [highly motivated PhD interested in translational occupational therapy research](#) in aging. The primary task of the postdoctoral research fellow will be to conduct research in the area of function and the environment for cognitively normal older adults aging in place. The focus of the research will be on identifying functional changes over time for older adults with and without preclinical Alzheimer disease and preventing falls among community dwelling older adults. The role involves working in a team-based environment and collaborating with different researchers on a range of projects. The research includes analysis and preparation of manuscripts for publication based on data from clinical studies, as well as the preparation and submission of grant proposals.

## SSO:USA Student Research Grant in Occupational Science – Request for Proposals

The fund will grant one or more modest annual financial award(s) directly to students who are engaged in (or propose being engaged in) research that will enhance and enlarge the body of knowledge in occupational science. Application deadline: April 30, 2017.

## Defense Health Program Psychological Health/Traumatic Brain Injury Research Program (PH/TBIRP)

The PH/TBIRP seeks to establish, fund, and integrate both individual and multi-agency research efforts that will lead to improved prevention, detection, and treatment of PH issues and TBI. It seeks to implement long-term strategies to develop knowledge and materiel products to reconstruct, rehabilitate, and provide definitive care for injured Service members. The intent of the PH/TBIRP CTRR is to focus on understanding the etiology, epidemiology, and natural history of TBI with the goal of improving clinical understanding of rehabilitation-relevant physiologic mechanisms; developing and validating rehabilitation outcomes or treatment strategies for management of TBI; and managing TBI-related sequelae, including pain and sensory, sensorimotor, and cognitive dysfunctions.

### Pipeline to Proposal (P2P) Awards Tier A Pre-Engagement/Community Projects

The P2P program now has two tiers. The first (Tier A) is designed to support the development of research partnerships as they identify a comparative clinical effectiveness research (CER) question (or series of questions) that is important to patients, researchers, and other members of the healthcare community. The second tier (Tier B) is designed to help research partnerships refine their Comparative CER questions and prepare an application for research funding. Funds available up to \$50,000.
